Electricity is available; we suggest bringing an extension cord. All extension cords must be taped down to the floor. SPONSOR Tables: There are four 6-foot skirted tables. Sponsor tables include 2 meal tickets, logo on flyers, and online exposure. Electricity is available; we suggest bringing an extension cord. All extension cords must be taped down to the floor. Vendors are strongly encouraged to bring a door prize to collect names and contact information at their table for follow-up.
